Health Effects:

ACUTE:

SWALLOWED: Moderately toxic. May cause irritation to mouth, throat, and digestive

tract. Large doses may cause drowsiness and may lead to unconsciousness. Liquid aspirated into the respiratory system during ingestion or from vomiting can cause severe bronchiopneumonitis or

ADVICE TO DOCTOR:

SWALLOWED: Symptoms; Irritation, nausea, vomiting, cramping. Central nervous system

depression from headache to anaesthesia. Risk of aspiration is main danger. If large quantity ingested gastric lavage should only be undertaken after endotracheal intubation. Give activated charcoal. Enforce bed rest. Maintain airway and vital functions. Observe for several days

for chemical pneumonitis, renal and hepatic injury.

INHALATION: Central nervous system depression characterised by headache and dizziness.

PRECAUTIONS FOR USE

EXPOSURE STANDARDS:

Threshold limit value (TLV) for xylene 100 ppm

ENGINEERING CONTROLS:

Good ventilation required. Ensure a minimum capture velocity of 0.5~m/sec at point of application – use local exhaust ventilation in enclosed areas to maintain concentration levels below the exposure limit set for the solvent. Refer to Australian Standards AS 1668.

PERSONAL PROTECTION:

RESPIRATORY PROTECTION: When applying by spray an Australian Standards approved half mask, air purifying respirator (cartridge - type) is recommended. Whenever workplace conditions warrant respiratory protection must conform with the requirements of AS1715 and AS1716.

EYE PROTECTION: Eye protectors, goggles, safety glasses, conforming to AS1337 recommended to prevent splashes entering eyes.
